This summer, Lake Greeley Camp, in association with Lander's River Trips, will conduct four 8-mile white water rafting excursions on the Upper Delaware River. While paddling through rapids and quiet pools, these excursions provide the opportunity to observe the diverse habitats along the river that support large number of wildlife, waterfowl, and waterbirds, including the bald eagle. Each rafting excursion launches from Barryville, NY and lands in Pond Eddy, NY; on average, a 5 hour trip.

Included with each excursion is a bagged lunch, lifeguard supervision, and all required safety equipment. To register, please complete the form below including the Release of Liability and Assumption of Risk Agreement. **Campers entering the 6th grade and older, who have passed the Deep Water Test and the River Safety and Paddling Test and can demonstrate swimming skills equivalent to Level 3 as defined by the American Red Cross, are eligible to participate in this activity.** The cost is \$40.00 per rafting trip.

Registration is on a first-come, first-served basis. **Payment must accompany this registration form.**

PARTICIPANT RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT

In consideration of being allowed to participate in any way at Lander's River Trips, related events and activities, I the undersigned, acknowledge, appreciate, and agree that:

- The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death.
- I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of Lander's River Trips or others, and assume full responsibility for my participation. I understand that this is a self-guided trip with no lifeguards or supervision on the river. I confirm that I am physically and mentally capable of participating in this trip.
- I willing agree to comply with terms and conditions for participation. If I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest official immediately.
- I acknowledge that I have swimming ability and that I will keep my life jacket on at all times. State law requires children under 13 to wear the life

jackets at all times or face penalty.

5. If, at any time, I realize that I am in waters above my ability to navigate, that I will immediately go to shore, and call for Lander's River Trips.

6. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release, indemnify, and hold harmless Lander's River Trips, its officers, officials, agents and/or employees, other participants, sponsors, advertisers, and if applicable, owners and lessors of premises used to conduct the event (Releasees), from any and all claims, demands, losses, and liability arising out of or related to any injury, disability or death I may suffer, or loss or damage to person or property, whether arising from the negligence of the releases if otherwise, to the fullest extent permitted by law.

I have read this Release of Liability and Assumption of Risk Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
