Teamwork, strategy, and the chance to splatter your friends is why paintball is such a blast. A session of paintball lasts for 3 hours and includes a safety orientation, 3-4 games, and 400 paintballs. Games are conducted on 2 paintball fields (one open field, the second is forested) which covers a variety of terrain and man-made obstacles. **Paintball is available to all campers entering the 5th grade and older.** Registration is on a first-come, first-served basis. The cost is \$30.00 per session.

Before a camper will be permitted to participate in this activity, a parent/guardian must sign the Waiver and Release of Liability Agreement. **No refund will be issued if a scheduled session of paintball is missed because a camper chooses to participate in another activity.** Sessions cancelled because of inclement weather will be rescheduled or refunded. **Payment must accompany this registration form.**

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of being permitted to participate in any way in the sport and activities of paintball under the auspices of Lake Greeley Camp, I acknowledge, appreciate and agree that:

- The risk of injury from the activity and weaponry involved in paintball is significant, including the potential for permanent disability and death, and while particular protective equipment and personal discipline will minimize this risk, the risk of serious injury does exist.
- I fully understand and acknowledge that:
 - risks and dangers exist in my child's participation in paintball activities and my child's use of paintball equipment.
 - my child's participation in such activities and/or use of such equipment may result in injury or damage to personal property including potential for permanent disability and death.
 - these risks and dangers may be caused by the paintball activity operator, camp staff members or other participants, or by accidents, or by the forces of nature or other causes. Risks and dangers may arise from foreseeable or unforeseeable cause including, but not limited to, selection of trail or uneven terrain on the playing field, weather conditions, injuries and/or welts or bruises caused by the paintballs, and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.
- I knowingly and freely assume all such risks, both known and unknown, even if arising from negligence of those persons released from liability below, and I assume full responsibility for my child's participation.
- I understand that the activities of paintball are physically and mentally intense. I understand that the rules of play will be reviewed with my child during the safety orientation class. I have instructed my child in the importance of knowing and abiding by the rules, regulations and procedures established for the safety of the paintball participants and my child has agreed to do so. I have further instructed my child to the attention of the nearest paintball instructor any unusual or unnecessary hazard observed during his/her participation in the activity.
- I, myself and on the behalf of my heirs, assigns, personal representatives and next of kin and on behalf of my child, hereby release, discharge, and agree to

hold harmless from liability, Lake Greeley Camp, its owners, directors, officers, employees and agents (releasees), with respect to any and all injury, disability, death or loss or damage to person or property, whether caused by the negligence of the releasees or otherwise, except that which is the result of gross negligence and/or wanton misconduct.

- I hereby certify that I, as a parent/guardian with legal responsibility for this participant, do consent and agree not only to his/her release of Lake Greeley Camp, and all other releasees but also agree to release and indemnify the releasees from any and all liabilities incident to his/her involvement in these programs for myself, my heirs, assigns, and next to kin.
- I understand and agree that this agreement covers each and every paintball activity and event in which my child participates hereafter.
- I hereby acknowledge that this waiver and release of liability, assumption of risk and indemnity agreement extends to all acts of negligence by releasees, and is intended to be as broad and inclusive as permitted by the law of Pennsylvania and that the balance shall, notwithstanding, continue in full legal force and effect.
- My child is in good health. I understand that strenuous physical exertion may be required and my child has no known physical disabilities or health problems which will present any risk to his/her participation in the activities.
- I have been advised that my child must wear approved protective eye goggles which will be provided by Lake Greeley Camp. No other padding, gloves or clothing is provided. Campers are required to wear long pants and long sleeved shirt when participating in the activity. It is recommended (but not required) that boys wear athletic supporters with cups. I also understand and agree that Lake Greeley Camp will not be held responsible for damages to clothing or personal belongings (Paintballs are water soluble, biodegradable, and nontoxic).
- I permit the use of any photographs, videos or sketches of my child taken during the activity for commercial purposes.
- I have read and agree to the terms of this release of liability and assumption of risk agreement, fully understand its terms, understand that I have given up substantial rights by signing it, and sign it freely and voluntarily without any inducement.
