Whether you prefer the bumps, the straightaways, or the puddles of mud, quad riding is exhilarating. Campers entering the 6th grade or higher are eligible to participate in this activity. Each participant will receive an orientation session that reviews basic ATV operation and safe riding techniques. Before riding the quad, they will then be evaluated on their ability to control the quad and their understanding of its operation. If, determined by the Quad Riding staff, a camper can not safely operate the quad, all program fees will be refunded.

The Honda 90cc ATVs are driven on the camp's gravel oval track. Lake Greeley Camp provides helmet and goggles. Campers must wear long pants and long-sleeved t-shirt or sweatshirt. The fee is \$25.00 for each 55-minute activity period.

Before a camper will be permitted to participate in this activity, a parent/guardian must sign the Waiver and Release of Liability Agreement. **No refund will be issued if a scheduled activity period of quad riding is missed because a camper chooses to participate in another activity.** Activity periods cancelled because of inclement weather will be rescheduled or refunded. **Payment must accompany this registration form.**

WAIVER AND RELEASE OF LIABILITY, ASSUMPTION OF RISK AND INDEMNITY AGREEMENT

In consideration of permitting my child to participate in the quad riding activity conducted at Lake Greeley Camp I, for myself and on behalf of my child, my personal representatives, heirs and next of kin do the following:

- I hereby acknowledge that quad riding is a potentially dangerous activity and involves the risk of serious injury and/or death and/or property damage. While particular equipment and personal discipline will minimize the risk, the risk of serious injury does exist.
- I fully understand and acknowledge that: (a) risks and dangers exist in my child's operation of a quad, (b) my child's participation in such activities and/or use of a quad may result in injury or damage to personal property including the potential for permanent disability and death, (c) these risks and dangers may be caused by the quad activity operator, camp staff members or other participants, or by accidents, or by forces of nature or other causes. Risks and dangers may arise from foreseeable and unforeseeable causes including but not limited to selection of quad track, trail or uneven terrain, weather conditions and such other risks, hazards and dangers that are integral to recreational activities that take place in a wilderness, outdoor or recreational environment.
- I understand that the activity of quad riding is physically and mentally intense. I have instructed my child in the importance of knowing and adhering by the rules, regulations and procedures established for the safety of quad riding participants and my child has agreed to do so.
- I hereby release, waive and discharge Lake Greeley Camp, its owners, directors, officers, employees and agents (the Releasees) from liability to myself or my child, my personal representatives, all assigns, heirs, and next of kin for any and all loss or damage and any claim or demands therefore on account of injury and/or death to my child and/or property damage, now and forever, arising out of or related to participating and/or instruction in said course, activities or any other related to quad riding operations that may occur whether caused by the negligence of the releasees or otherwise.
- I hereby assume full responsibility for any risk of bodily injury, death or

property damage, now and forever, arising out of or related to participation and/or instruction in said course, activities, or any related quad riding operation, whether foreseen or unforeseen and whether caused by the negligence of the releasees or otherwise. I hereby separately agree to indemnify and save and hold harmless the Releasees from any loss, liability, damage or cost that they may incur, now and forever, arising out of or related to my child's participation and/or instruction in said course, activities, or any other related quad riding operations, whether caused by the negligence of the Releasees or otherwise.

6. I hereby acknowledge that this Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by Releasees, and is intended to be as broad and inclusive as permitted by the laws of Pennsylvania and that if any portion thereof is held valid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect.

7. I have read the Waiver and Release of Liability, Assumption of Risk and Indemnity Agreement, fully understand its terms, understand that I have given up substantial rights by signing it, am aware of its legal consequences and have signed it freely and voluntarily without any inducement, assurance, or guarantee being made to me or my child and intend my signature to be a complete and unconditional release of liability to the greatest extent allowed by law.

8. As a parent or guardian with legal responsibility for this participant, acknowledge that I am signing this document on behalf of my minor child and agree to be specifically bound to all of the terms and conditions of this agreement. I have read the agreement, fully understand the terms therein, understand that I have given up substantial rights by signing it, am aware of its legal consequences, and have signed this document freely and voluntarily without any inducement, assurance or guarantee being made to me. I intend my signature to be complete and unconditional release of all liability to the greatest extent allowed by law further agree to indemnify and save and hold harmless the Releasees.
